Note #8: Change note from A-27 to “A-25”.

Note #9: Delete reference to foundation pad A13.

Note #11: Change note to read: “Steel plate AND BRACKET supporting flume at B-4 shall be replaced with pre-drilled galvanized steel plate AND BRACKET, matching in dimensions to existing.”
