The Peoria Park District is soliciting written quotes for the replacement of private fire hydrants at the Riverplex Recreation and Wellness Center.

Please note that the prevailing rate of wage including benefits for the Peoria area shall be paid for each craft or type of worker needed to execute this project or perform this work as required by the State of Illinois Department of Labor.

General Description and Scope of Work:

- A. General: This project's intent is to replace in their entirety two private fire hydrants at the Riverplex.
 - a. Hydrant #24 NW corner of building
 - b. Hydrant #27 NE Corner of building

B. Products:

a. All products must be compatible with previously installed hydrants and piping, Illinois American Water Company specifications, and City of Peoria regulations.

C. Execution:

- a. Follow all City of Peoria and Illinois American Water Company procedures for work on private water mains.
- All hydrants shall be tested by contractor in the presence of the Owners Representative before final acceptance.
- c. Excavations shall be filled and compacted when complete.
- d. Old hydrants shall be delivered to the Park District's Equipment Service Center in Bradley Park.

Administrative Requirements

We are required by State law and Park Board policy to request the following to be submitted with quote. Unfortunately, Quotes submitted without this information are considered incomplete and ineligible for award. If needed, these forms may be faxed or emailed to you for your use.

- 1. <u>EEO Certification</u> A completed Certificate of Equal Employment Opportunity Compliance must be submitted with quotes if not currently approved.
- Workforce Profile A completed Workforce Profile must be submitted if not currently approved.
- 3. <u>Sexual Harassment Policy</u> A sexual harassment policy must be submitted for approval if not currently on file.
- 4. W-9 Taxpayer Identification Form: Bidder must complete and sign the W-9 form.
- 5. <u>Substance Abuse Prevention Program Certification</u> Submit form with appropriate section completed. If Part B of the form is completed, your company's Substance Abuse Policy must be submitted for approval.
- 6. <u>Certification of Safety Compliance</u> A completed certification of safety compliance must be submitted.
- 7. <u>Illinois Drug Free Workplace Certification</u> A completed Illinois Drug Free Workplace Certification (form attached) must be submitted.

Required forms after Award is made before work can begin:

1. <u>Insurance Requirements:</u> A Certificate of Insurance and Endorsement with a minimum of one million (\$1,000,000) of liability coverage, naming the Peoria Park District as Additional Insured, will be required, before work begins. Verification that all employees who will be working at the site are currently covered by Workers Compensation Insurance will also be required.

- 1. <u>Certified Payroll</u> Prevailing wage is required for this job. A certified payroll form must accompany all requests for payment.
- 2. <u>Weekly Workforce Reports</u> Contractor shall submit completed Weekly Workforce Report for each week until project is completed.
