I. DRAWINGS:

Clarification: For bidding purposes, assume CMU reinforcement is covered by Addendum #1 details on Romtec sheet 7. If final engineered plans are different from bidding details, a change order may be considered.

Sheet C310: Clarification: The plan review refers to a drinking fountain service line. The drinking fountain, base, concrete slab mount, and French drain will be provided and installed by Owner. Contractor shall leave capped, exposed piping whip at location to be determined in field by Owner not to exceed 75' from new restroom building.

II. PROJECT MANUAL/SPECIFICATIONS/GENERAL CONDITIONS/ETC.:

Clarification: Painting. Under "Romtec Scope of Supply and Services" Paragraph D, sub. Par. i: "Interior wall and floor finish will be epoxy paint, supplied and applied by the *installer*."

Exterior wood fascia comes from manufacturer primed, and shall be painted by contractor to match roofing. Timber truss and post will arrive raw, and shall be painted by installer with two coats clear wood finish, equal or better than Cabot 2101 series Clear Wood Protector, also to be provided by installer.

Roof : Roof materials supplied by Romtec include 2x6 tongue and groove decking, an OSB underlayment, 30lb roofing felt, and metal roofing. No furring or insulation is required.

Signage: Romtec will provide signage for the restrooms.
