The proposed Contract Documents for this Work are modified as follows:

- I. PROJECT MANUAL / SPECIFICATIONS/GENERAL CONDITIONS/ETC:
 - A. Section 051200 It is noted paragraph 2.7 A. 2. Reads "Galvanize all exterior exposed steel". There will be no painting of steel required.
 - B. Section 230710:

1. Paragraph 2.02.D: Add sentence. Elbow covers for Victaulic type pipe shall include molded space for coupling clamp and insulation. 2. Add paragraph 3.03.B.6 "Insulate Victaulic fittings and clamps with narrow wrappings of 1" thick fiberglass blanket insulation. Finish with a pre-molded insulation cover; specifically made for the "Victaulic" pipe.

- C. Section 232113:
 - 1. Under paragraph 2.04 the second paragraph A and following paragraphs B,C and A shall all be deleted. Add these paragraphs in their stead.
 - "B. At Contractor's option Pipe fittings 2 " and above, shall be Victaulic PGS-300 grooved end type with type 356 and 357 fitting clamps. Reducing clamps shall not be used. Pipe size reductions shall be made per paragraph 3.02.R.3 or as noted in item 2 below.
 - C. Pipe 2" in diameter shall utilize solvent cement connections as noted above.
 - 2. Under paragraph 3.02.R add subparagraph: "5. Use of reducing 'tees'
 and 'couplings' is acceptable."

II. DRAWINGS:

Regarding the note on Drawing DH-101 which begins "PUMP DOWN AND COLLECT REFRIGERANT..." change that note to read. "EXISTING REFRIGERANT EQUIPMENT DATA Listed A TOTAL REFRIGERANT CHARGE OF APPROXIMATELY 830 LBS OF R22 ORIGINALLY. IT HAS BEEN OBSERVED THE SYSTEM MAY HAVE UP TO 1400 LBS. (LEAKAGAGE RATES ARE UNKNOWN). CONTRACTOR SHALL PUMP DOWN AND REMOVE ALL REFRIGERANT. DELIVER 100 LBS TO THE OWNER IN CANISTERS FURNISHED BY THE OWNER. THE REMAINING REFRIGERANT

Natatorium HVAC Replacement RiverPlex Recreation and Wellness Center SHALL BECOME THE PROPERTY OF THE CONTRACTOR. REMOVE THE EXISTING CONDENSING UNIT, WHICH WEIGHS APPROXIMATELY 4200 POUNDS AND ASSOCIATED PIPE"
