I. GENERAL ITEMS

- A. Crane Access for Condenser Removal and Fluid Cooler Installation
 - 1. Coordinate with the Owner at least 7 days before date of the work.
 - 2. Shall not impact traffic coming to the front entry from Irving Street.
 - 3. Time period allowed shall not be longer than 4 hours in length.
 - 4. Does not need to be on a weekend or holiday.
 - 5. Shall shut down Water Street entry and parking up thru to the S.W. side of the main entry. Contractor is responsible for any required city permits.
 - 6. Traffic barriers and signage shall be provided by the contractor.
 - 7. Separate occasion for crane access shall be allowed once for removal of existing condenser and once for the installation of the new fluid cooler.
- B. Man lift dimensions and weight are limited only by the doorway dimensions entering into the space. Lift routing within the space shall be protected with plywood. Lift stabilizers shall be set on planking and timbers to protect surfaces, drain grates and other devices. Any damage to pool deck shall be repaired at Contractor's expense.
